EAST PANTHER CREEK DRIVE

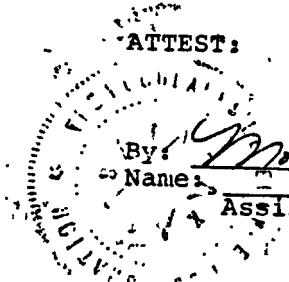

COMMENCING for reference at the northwest corner of a 16.0044 acre tract dedicated as Woodlands Parkway in Volume 949, Page 358 of the Montgomery County Deed Records;

THENCE S 63°49'22" E, 144.62 feet along the northerly right-of-way (R-O-W) line of said Woodlands Parkway to the PLACE OF BEGINNING;

THENCE 39.66 feet along the arc of a curve to the left (Delta = 90°54'18", Radius = 25.00', Chord = N 70°43'29" E, 35.63') to a point at the end of curve;

THENCE N 25°16'20" E, 435.91 feet to a point at the beginning of a curve;

THENCE 536.54 feet along the arc of a curve to the left (Delta = 27°05'05", Radius = 1135.00', Chord = N 11°43'47" E, 531.55') to a point at the end of curve;

THENCE N 01°48'45" W, 181.09 feet to a point at the beginning of a curve;

THENCE 1317.70 feet along the arc of a curve to the right (Delta = 75°29'55", Radius = 1,000.00', Chord = N 35°56'12" E, 1224.42') to a point at the end of curve;

THENCE 597.99 feet along the arc of a curve to the right (Delta = 27°05'05", Radius = 1265.00', Chord = S 11°43'47" W, 592.44') to a point at the end of curve;

THENCE S 25°16'20" W, 438.75 feet to a point at the beginning of a curve;

THENCE 38.88 feet along the arc of a curve to the left (Delta = 89°05'42", Radius = 25.00', Chord = S 19°16'31" E, 35.08') to a point at the end of curve and in the northerly R-O-W line of said Woodlands Parkway;
